Is Litter-on-a-Stick Illegal in Katy?

Dear Kayla,

We called County Commissioner Steve Radack to ask about those bandit signs and it looks like Katy may be in for some sign relief on Mason Road, Fry Road and other Harris county streets. According to Radack, a new law just went into effect on September 1, 2007 (H.B. 413). This law allows local officials to issue citations for bandit sign violators at a cost of \$500-\$1000 per sign. A separate penalty may be collected for each day a continuing violation occurs. Radack assured me that violators will definitely be fined for signs left on Harris County streets. —Katrina Katsarelis, Katy Magazine Editor
